Pursuant to the provisions of Article 23 of the Statute of the Faculty of Medicine of the University of Rijeka (CLASS: 007-05/24-01/01; REG. NO.: 2170-1-42-01-24-1, dated January 18th, 2024 - purified text), at the electronic session held from October 3rd 2024 to October 8th 2024, the Faculty Council adopted the following

## DECISION

### I.

Students at the University Integrated Undergraduate and Graduate Study of Medicine in English who will enroll in the higher year of study in the academic year 2025/2026 (second, third, fourth, fifth, and sixth year of study) are approved to pay the tuition fee as follows:

- 60% upon enrollment
- 40% by October 31 of the current year.

### II.

For the generation enrolled for the first time in the academic years 2017/2018, 2018/2019, and 2019/2020, for which the tuition fee is EUR 9,000.00 (nine thousand euros) which is EUR 150,00 per 1 ECTS, the payment dynamics of tuition fee is as follows: the student is required to pay the first part (EUR 5,400.00) upon enrollment, the second part (EUR 3,600.00) by October 31, 2025.

### III.

For the generation enrolled for the first time in the academic years 2020/2021, 2021/2022, 2022/2023, 2023/2024 and 2024/2025, for which the tuition fee is EUR 10,000.00 (ten thousand euros), which is EUR 166,67 per 1 ECTS, the payment dynamics of tuition fee is as follows: the student is required to pay the first part (EUR 6,000.00) upon enrollment, the second part (EUR 4,000.00) by October 31, 2025.

### IV.

The decision shall be binding from the date of its adoption.
