On the basis of Article 23 of the Statute of the Faculty of Medicine in Rijeka (CLASS: 007-05/23-01/03; REG. NO: 2170-1-42-01-23-1 of April 17, 2023), the Resolution of the Faculty Council amending the Statute of the University of Rijeka, Faculty of Medicine (CLASS: 007-06/23-02/518; REG. NUMBER: 2170-1-42-01-23-01 of November 14, 2023) and the Resolution amending the Statute of the University of Rijeka, Faculty of Medicine (CLASS: 007-06/24-02/690, REG. NUMBER: 2170-1-42-24-01-1 of December 17, 2024), the Faculty Council of the University of Rijeka, Faculty of Medicine, with its registered office in Rijeka, Braće Branchetta 20, OIB: 98164324541, at the proposal of the Teaching Committee at the XXI. electronic session from September 05. to 09. 2025, on September 09, 2025, decides the following

RESOLUTION

I.

The students of the University Integrated Undergraduate and Graduate Study of Medicine in English who will enroll in the academic year 2026/2027 in the senior year of study (second, third, fourth, fifth, and sixth year of study) agree to pay the tuition fee as follows:

- 60% upon enrollment
- 40% by October 30 of the current year.

II.

For the generation enrolled for the first time in the academic years 2017/2018, 2018/2019 and 2019/2020 for which the tuition fee is EUR 9,000.00 (nine thousand euros) which corresponds to EUR 150,00 per 1 ECTS, the payment dynamics of the tuition fee is as follows: the student must pay the first part (EUR 5,400.00) upon enrollment, the second part (EUR 3,600.00) by October 30, 2026.

III.

For the generation enrolled for the first time in the academic years 2020/2021, 2021/2022, 2022/2023, 2023/2024 and 2024/2025 and for which the tuition fee is EUR 10,000.00 (ten thousand euros), which corresponds to EUR 166,67 per 1 ECTS, the payment dynamics of the tuition fee is as follows: the student must pay the first part (EUR 6,000.00) upon enrollment, the second part (EUR 4,000.00) by October 30, 2026.

IV.

For the generation enrolled for the first time in the academic year 2025/2026 and for which the tuition fee is EUR 12,000.00 (twelve thousand euros), which corresponds to EUR 200,00 per 1 ECTS, the payment dynamics of tuition fee is as follows: the student must pay the first part (EUR 7,200.00) upon enrollment, the second part (EUR 4,800.00) by October 30, 2026.
